## 3. HAZARDS IDENTIFICATION

Classified as hazardous according to criteria in the HS (Minimum Degrees of Hazard) Regulations 2001.

## 4. FIRST AID MEASURES

**Inhalation:** Remove victim from area of exposure - avoid becoming a casualty. Seek medical advice if effects persist.

**Skin Contact:** If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.

**Eye Contact:** If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

## 5. FIRE FIGHTING MEASURES

**Specific Hazards:** Non-combustible material.

**Fire-fighting advice:**

Decomposes on heating emitting toxic fumes, including those of oxides of carbon. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

**Suitable Extinguishing Media:**

Not combustible, however, if material is involved in a fire use: Water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

## 6. ACCIDENTAL RELEASE MEASURES

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Avoid breathing in dust. Work up wind or increase ventilation. Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.

## 7. HANDLING AND STORAGE

**Handling advice:** Avoid skin and eye contact and breathing in dust.

**Storage advice:** Store in a cool, dry, well ventilated place and out of direct sunlight. Keep containers sealed as material may absorb moisture. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Occupational Exposure Limits:**

No value assigned for this specific material by the New Zealand Occupational Safety and Health Service (OSH). However, Workplace Exposure Standard(s) for particulates:

WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

**Engineering Control Measures:**

Ensure ventilation is adequate to maintain air concentrations below Exposure Standards. Avoid generating and breathing in dusts. Use with local exhaust ventilation or while wearing dust mask. Keep containers closed when not in use.

**Personal Protective Equipment:**

Minimum recommended requirements: OVERALLS, SAFETY SHOES, SAFETY GLASSES, GLOVES, DUST MASK.

Wear overalls, safety glasses and impervious gloves. Avoid generating and inhaling dusts. If dust exists, wear dust mask/respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use.
